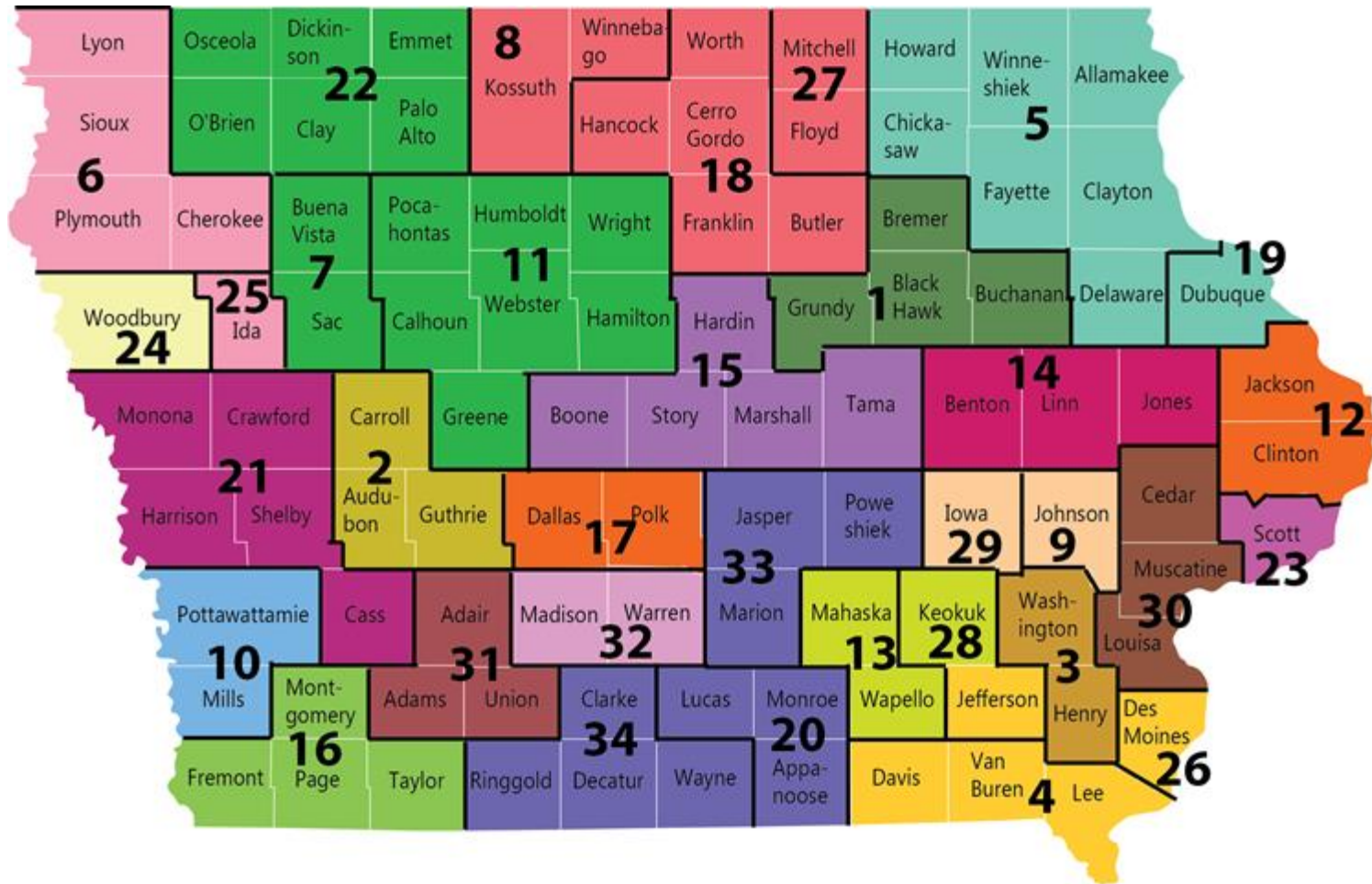


Healthy Child Care Iowa Map
